6. Accidental Release Measures

Personal precautions, protective equipment and emergency procedures Keep unnecessary personnel away. Avoid generation and spreading of dust. Avoid inhalation of dust and contact with skin and eyes. Use a NIOSH/MSHA approved respirator if there is a risk of exposure to dust/fume levels exceeding the exposure limits. Methods and materials for containment and cleaning up

Stop the flow of material, if this is without risk. If sweeping of a contaminated area is necessary, use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Avoid release to the environment. Following product recovery, flush area with water. For waste disposal, see section 13 of the SDS.
